5 ACDBL - LEAGUE RULES

The following points are brought to the attention of each Club.

1. It is a recommendation of the League Committee that Clubs should hold their A.G.M. prior to the A.G.M. of the League so that they are represented at this meeting by their newly appointed officers. Also, any matters that are raised at the Club A.G.M. can be discussed at the League A.G.M. providing that appropriate notice is given or is raised in "Any Other Business".
2. The Fees for admission to the League for the 2003/2004 season are:
 - a) Affiliation Fee £15.00 per Club
 - b) Team Subscriptions £12.00 per Team.

Fees are due at commencement of season.

3. Before the commencement of a League Ladies, Mens or Mixed match the opposing team Captains should agree the order of play from the following:

4. There is no fixed rule on the scoring/umpiring of matches, it being a matter for the individual clubs to determine whether they wish to have their matches scored/umpired by participating players.

5.1 ACDBL - General Rules

1. NAME

The League shall be called the ALDERSHOT AND CAMBERLEY DISTRICT BADMINTON LEAGUE.

2. OBJECT

The object of the League shall be to foster and promote Badminton in the Aldershot and Camberley district areas.

3. MEMBERSHIP

Any club in the district that has, in the opinion of the committee, reasonable playing conditions shall be eligible to apply for membership if they wish to, providing that they affiliate to the appropriate County Association and the Badminton Association of England by the end of October each year.

4. SUBSCRIPTIONS

There shall be an annual affiliation fee plus team entry subscriptions payable by member clubs, the amount of which shall be fixed at the A.G.M.

5. LAWS

All play shall be in accordance with the Laws of Badminton as defined by the Badminton Association of England.

6. MANAGEMENT COMMITTEE

The affairs of the League shall be conducted by an annually elected Management Committee which shall consist of the following Honorary Officers: Chairman, General Secretary, Treasurer, Tournament and External Match Secretary, Internal Match Secretary, and up to 4 ex-officio members. The Committee shall have the power to appoint sub-committees as necessary.

The Officers and Committee shall be elected at the Annual General Meeting of the representatives of member clubs.

Should a vacancy occur on the Management Committee, then the Committee shall be empowered to co-opt as necessary, provided that there remains two thirds of elected members.

7. ANNUAL GENERAL MEETING

The Annual General Meeting shall be open to any member of a member club, but voting will be restricted to two representatives per club. The A.G.M. shall be held either in the last week of June or the first week of July.

8. GENERAL MEETINGS

The Secretary shall call an Extraordinary General Meeting at the request of the Committee, or upon the written request of five clubs stating the purpose for which the meeting is to be called.

9. LEAGUE FIXTURES

The League season shall commence no earlier than the 1st September and all matches shall be completed no later than the 30th April of the following year.

Any extension to the league season for loss of venue or extreme circumstances unforeseen must be applied for and agreed by the Internal Match Secretary prior to the match taking place.

If deemed necessary, the League Management Committee shall make arrangements for a League Fixture Meeting to be held at the end of July or the beginning of August which will be notified to all members clubs.

Fixtures may not be arranged earlier than the Annual General Meeting whereupon information packs will be distributed to all Match Secretaries. They will be required to submit club fixture information in a specified format to the Internal Match Secretary no later than 21 days prior to the beginning of the official season.

In the event of *two* teams from *one* club playing in the same division, the fixtures between the teams shall be played before any fixtures with other clubs in the division.

The earliest start time for Senior League fixtures on Monday to Friday inclusive shall be 19.00 hours unless an earlier time is mutually agreed, by both clubs.

10. SHUTTLECOCKS

Shuttlecocks shall be provided by the home team. Feather shuttles shall be used throughout the Divisions.

11. TEAMS

Ladies, Mens and Mixed sixes teams will consist of 3 pairs; each pair will play two games against each of the opposing pairs.

Ladies and Mens fours teams will consist of four players (numbered 1 to 4); in Mens each player will take part in 4 rubbers of 2 games, and ladies 3 rubbers of 2 games, in which each game shall be to 15 points with no setting.

Mixed fours teams will consist of four players, 2 men and 2 ladies; each player will take part in 3 rubbers of 2 games in which each game shall be to 15 points with no setting.

A player may represent more than one club providing:

- a) They do not play for more than one club in the same section i.e. Ladies, Ladies 4's, Mens, Mens 4's, Mixed or Mixed 4's.
- b) They are bona fide members of each club for which they play and are so registered with the League.

During the course of a season a player may only transfer and represent another club in league matches with the prior written approval of the Management Committee.

Should one or more of the 4/6 players fail to turn up or be injured during the course of a match, the games in which these players failed to take part shall be awarded to the opposing club with a score of 15-0.

12. DIVISION

The League shall be run in as many divisions as it is deemed necessary by the Committee, and the size of each division shall be left to the discretion of the Committee, up to a maximum of 8 (eight) clubs per division. Each club shall play a home and away match against each other club in its own division.

13. AWARDING OF POINTS

For Mens, Ladies and Mixed matches, match points will be awarded as follows:

Win	2 points
Draw	1 point

In Fours matches each pair will play 2 games to 15 with no setting. The match result will be decided on total game points (maximum 240 for Mens and 180 for Ladies 4's and Mixed 4's). If the winning margin is 30 (Mens) or 25 (Mixed & Ladies) game points or greater then 3 match points will be awarded to the winners and 0 to the losers. If the winning margin is less than 30 (Mens) or 25 (Mixed and Ladies) game points then 2 match points will be

awarded to the winners and 1 to the losers. In the event of a draw then each team will receive 1.5 match points.

The final position of each team within a division shall be decided by the total number of match points gained. If 2 or more clubs have an equal number of match points, then their positions shall be decided by the total number of rubbers (Ladies, Mens, or Mixed) or game-points (Ladies, Mens and Mixed Fours) won during the season.

If, at the end of the season, clubs are equal on match points and rubbers and game-points and promotion or relegation is involved, then those clubs shall be required to arrange a play-off match in, if possible, a neutral hall, sharing expenses etc. In the event of the match result being a draw, then the team scoring the most games (Ladies, Mens or Mixed 6's) or game-points (Ladies, Mens or Mixed 4's) shall be declared the winners.

14. NOTIFICATION OF RESULTS

The winning team in a league match shall be responsible for sending in the match card. In the case of a draw, the home team shall be responsible for sending in the match card. The home team shall supply the match card. Should a match be cancelled and conceded it is the responsibility of the winning team to inform the Internal Match Secretary of the result.

A deduction of one point shall be made from the team responsible for sending in a match card or, in the case of cancelled and conceded matches, informing the Internal Match Secretary of the result, if it is received more than 14 days after the match date. Freepost has been introduced to help aid the submission of match cards on time.

Any result not received by the Internal Match Secretary 14 days after the end of the official league season shall be awarded 9 – 0 to the non-defaulting team.

15. REGISTRATION & NOMINATION OF PLAYERS

All clubs must submit, to the Internal Match Secretary, names and telephone numbers in the specified format for all registered players 7 days before the start of their fixture obligations.

All other players must be registered at least 48 hours prior to taking part in a league match or tournament.

- a) Any club competing in more than one division of the same League shall, before playing a second team fixture, nominate its first team players; and before playing a third team fixture, its first and second team players. This rule to be extended to fourth and subsequent teams as necessary.
- b) Any proposed deletion of a nominated player from a team must be accompanied by a substitute nomination. Seven (7) clear days notice in writing must be given to the Internal Match Secretary.

Players who have not yet played for a nominated team may be re-nominated to another team provided the Internal Match Secretary is notified in writing before the match is played.

Players who have played for a nominated team may only play in a lower team if the Internal Match Secretary is notified that the player has been dropped for the remainder of the season, and may not then play for a higher team under any circumstances. After the 1st March, no nominated player may play in a lower team.

Any member representing his/her club in more than three League matches in a senior team will, after that, not be eligible to play League matches in a more junior team for that season.

- c) Any infringement of this rule or Rule 11 will result in the loss of rubbers in which the offending player takes part unless, on appeal, the Management Committee shall decide otherwise.

16. NEW CLUB / TEAM ENTRIES

New teams entering the League will normally enter the lowest division. Alternatively, a new team may express a wish to join in a higher division. The new team shall apply in writing to the League Committee, who in consideration of the prospective strengths of the new team and the existing divisions may at their discretion enter the team in any division not higher than the mid-point of the divisional structure.

17. PROMOTION AND RELEGATION

At the end of each season, the leading team in each of the lower divisions shall be promoted to the division above and the bottom team in each of the higher divisions shall be relegated to the division below. Normally the 2nd from top and 2nd from bottom will also be promoted or relegated as well but, exceptionally, and at the discretion of the committee, they may either remain in the same division or be promoted or relegated along with adjacent teams, in order to accommodate the provisions of other rules.

At the discretion of the Committee accelerated promotion may be awarded to teams of exceptional proven ability. The Committee may also consider relegation of more than one division for teams unable to maintain an acceptable standard in the division for which they have been playing. Clubs wishing to be considered for accelerated promotion or relegation shall apply to the League Committee in writing no later than 21 days before the date of the AGM.

No more than two teams from any one club shall compete in a single division of the League. Should a third team finish in a promotion position, the League Management Committee shall be empowered to either:

- a) Promote the next team below, or
- b) Allow the higher of the two teams due for relegation to remain in the division in question.

18. UNFINISHED MATCHES

If a match is unable to be finished due to lack of time, the away team shall be awarded the unfinished games, providing play commenced within fifteen minutes of the appointed time. If either team does not arrive within fifteen minutes of the appointed time then Rule 19 applies.

19. LATE START OF MATCHES

If play does not commence on all courts available for match play within 15 minutes of the appointed start time as per the League handbook, owing to the late arrival of sufficient members of either team, the first rubber/s so affected shall not be played and shall be awarded to the non-defaulting side before the commencement of the match.

For every period of 15 minutes thereafter in which play does not commence on each available court, through default of either team, one rubber, which shall not be played, shall be awarded to the non-defaulting side.

Should a team not arrive at the stated handbook venue then the team who have arrived at the venue should remain until 75 minutes after the stated handbook start time before any player leaves. This allows the non-defaulting side to claim a minimum of 5 games, and, therefore a match win. An attempt should be made to contact both the respective club match secretaries immediately.

In the event of any dispute, the matter should be reported to the General Secretary for the attention of the Management Committee.

The non-defaulting side may waive this rule at the start of the match.

20. CANCELLED OR POSTPONED MATCHES

Matches shall be played on the date agreed between the clubs concerned prior to the beginning of the season and published in the League handbook except where it is not

possible for reasons beyond the control of their club (e.g. inclement weather or the withdrawal of playing facilities). Such an eventuality shall be subject to Rule 20a) 1 & 2.

As an additional exception, clubs may re-arrange matches by mutual consent. However, neither club may expect to be offered a re-arrangement, nor shall either club be obliged to offer one.

If an amicable agreement cannot be reached between the two clubs concerned for a cancelled or postponed match to be played at a later date, then the following shall apply:

a) If a home or away team cancels a match or if one of the two teams concerned fail to turn up on the appointed day and time as listed in the official match programme published in the Handbook, or as amended under section b) below then the match shall be awarded to the non-defaulting club with the following two exceptions.

1. Inclement weather. If the cancellation is due to inclement weather, then a revised fixture convenient to both sides shall be arranged by the home team. In the event of the home team not being able to arrange an alternative and convenient fixture in their own hall, then a match shall take place in a neutral hall on a date acceptable to both sides, and in these circumstances, any additional expenses, if any, shall be borne by both sides. Should it not prove possible to re-arrange within these terms then the match shall be treated as a draw.

2. Loss of Venue. If the cancellation is to the loss of facilities then the club concerned shall make arrangements for an alternative fixture date to be mutually agreeable to both sides. If the home club is unable to find an alternative convenient date to suit their opponents in respect of the scheduled venue, then the home club shall be responsible for finding an alternative venue at their own expense on a date which is acceptable to their opponents.

In the event of agreement not being reached as to a suitable alternative date, then the matter shall be referred to the Management Committee for a decision to be determined, but in this event, it could result in the match being deemed as unplayed, and no points or rubbers will be credited to either side.

b) Once the official programme has been published, and in the event of matches being re-arranged, both sides shall be responsible for informing the Internal Match Secretary in writing of their agreement to the re-arrangement, giving particulars as to the teams concerned; the venue, date and time.

c) In the event of the away team cancelling or re-arranging a match for reasons other than that of inclement weather, then the home team may, at their discretion, levy on the defaulting club a fee sufficient to cover all financial losses incurred by the home club on courts booked but not used. The amount of notice given for the cancellation will not be a consideration on the charges levied. The home club will have to produce evidence of the incurred costs if asked to do so.

This cancellation fee should be received by the home team within 14 days of the cancelled match date or receipt of the evidence of the costs whichever is later. Failure to pay, may, at the Committee's discretion, lead to the exclusion of that team from the League the following season.

If the teams agree to re-arrange by mutual consent and the away team had defaulted, then they have to take responsibility for finding a venue and a date for the re-arrangement, if requested to do so. The original home team covers the cost. If no suitable arrangement can be made the defaulting team has to concede.

In the event of a team requiring a re-arrangement, notice of the match details must be submitted in the specified format to the Internal Match Secretary by the defaulting team no later than 14 days after the published date.

If the information is not received within the time agreed then a single penalty point would be applied to the defaulting team.

Exceptions to this rule shall be loss of venue and inclement weather whereupon the Internal Match Secretary will deal with the club on a one to one basis.

21. LETS AND FAULTS

Any member club of the League may, at any time before the end of August, refer any club to the League Committee for arbitration on the club's regulations concerning faults and lets caused by their hall's structure.

22. CUPS AND SHIELDS

None of the Cups or Shields presented to Tournament or League Divisional Winners can be won outright. These remain the property of the League.

23. APPOINTMENT OF HON. AUDITOR

An Auditor shall be appointed by the League, and this appointment shall be made at the Annual General Meeting of the representatives of the Member Clubs.

24. PROPOSITIONS TO AMEND RULES

Any propositions shall be sent in writing to the Committee, 21 (twenty one) days before the A.G.M.

25. DISSOLUTION OF THE LEAGUE

If at any general meeting of the League, a resolution is passed calling for the dissolution of the League, the secretary shall immediately convene a Special General Meeting of the League to be held not less than one month thereafter to discuss and vote on the resolution.

If at that Special General Meeting the resolution is carried by at least two-thirds of the full members present at the meeting, the General committee shall thereupon, or at a date specified in the resolution, proceed to realise the assets of the League and discharge all debts and liabilities of the League.

After discharging all debts and liabilities of the League, the remaining assets shall not be paid or distributed amongst the full members of the League, but shall be split 3 ways between junior badminton counties: Hampshire, Surrey and Berkshire, for the development of junior badminton.

26. DISTANCE

For new clubs wishing to join the League they must play within a 15 mile radius, measured from Farnborough Recreation Centre.

9 TOURNAMENT RULES

9.1 Ladies, Mens and Mixed Doubles

1. As decided by the Laws of the Badminton Association of England, the Tournament is classed as Restricted, and as such is limited to bona-fide members of Clubs in the League who must have been registered with the League at least 7 days before taking part in a League Tournament by the relevant Club. Organisers of affiliated junior clubs may also play.
2. Players must be registered players of the league. Players under 16 years of age must be members of a Senior League Club. Players who are unable to obtain a partner from within their own club may apply to join the partnership pool to be drawn by the Committee.
3. Entry forms plus fees must reach the Tournament Organiser before the closing date for the tournament, and must be signed by the entrants. Entries will not be guaranteed after the closing date. Late entries will be put onto a reserve list.
4. If entries cannot be accepted, the fees will be refunded, but in no other circumstances will a refund be made.
5. The Committee reserve the right to refuse any entry without assigning a reason, also to alter or modify the programme in any way they see fit.
6. Competitors must be prepared to play when called upon, and if not available when called, will be disqualified.
7. Medium speed, feather shuttles will be used.
8. Competitors must be dressed in suitable badminton apparel. Track suits may be worn at the discretion of the Tournament Committee.
9. The draw for the tournament will be sent to all Club Secretaries approximately 10 days before the Tournament. If one player of a listed partnership cannot play, substitutions can be made (subject to conditions 1 & 2 above) provided the Tournament Organiser is informed 24 hours before the tournament commences. After this time substitutions will be at the discretion of the tournament committee. If a player is injured during the tournament, or is sick, the entrant or partnership as a whole must withdraw. Once the draw is known, club pairs cannot be changed from group to group.
10. If a pair cannot play, then they must inform the Tournament Organiser at once so that the vacancy can be filled. Entry fees will not be refunded to players who withdraw after the draw of the tournament has been made.
11. Special Rules for specific tournaments, when applicable, will be displayed at the time of the tournament.
12. Prizes will be awarded appropriate to the tournament, and at the discretion of the Tournament Committee.
13. In the case of dispute or interpretation of the Rules, the decision of the Tournament Committee shall be final.

9.2 Ladies and Mens Singles

Rules 1 - 13 apply with an appropriate amendment to Rules 2 & 9. The reading throughout should, of course, be treated in the singular.

9.3 Veterans Doubles (Handicapped)

Rules 1 & 3 - 13 apply with the following amendments:

- a) In the case of Rule 1, only one player of a listed partnership need be a bona-fide player of a member club.
- b) Competitors to be 40 years or over, at the date of start of tournament.
- c) Number of entries restricted.
- d) Players are welcome to enter a pool for all events.

9.4 Team Tournament

Rules 1 - 13 apply in addition to the following rules:

- a) Each match will comprise nine doubles games, namely 3 mens, 3 ladies, and 3 mixed. Each game will be played to 21 points with no setting. The team with the highest number of points at the conclusion of the match will be declared the winner. In the event of both teams scoring an equal number of points, the team winning the most number of games will be declared the winner.
- b) Each match will be allocated a session of 3¼ hours on one court. There will be a 15 minute changeover period between sessions. After 3¼ hours of play a whistle will be blown and the score at that point will be taken as the final result. It is essential that play starts on time and no delay occurs between games, and it will be the responsibility of the nominated captains to ensure that the match proceeds smoothly, and as quickly as possible. It will also be the joint responsibility of the captains to record the result of each game, on the official score sheet.
- c) Each team entered must be submitted on the nomination form in order of playing ability for mens and ladies doubles, with a separate ability listing for mixed pairs. If a player is substituted, the order of playing ability must be re-submitted at the same time. No changes can be made on the day of the tournament.
- d) Once a player has been nominated, he/she may not play for a lower team. In the event of a player being unavailable on the day of the tournament, a substitution may be made with the consent of the Tournament Secretary. 24 hours notice should be given, after which substitutions will be at the discretion of the Tournament Committee. The substituted player should be no stronger than the player he/she replaces. Once a player has been substituted, the substituted player becomes the nominated player for the team.
- e) Players must be from the same club, that is the club for which they play Mixed League Matches, as defined in Rule 11 of the League.
